### What to do when you open the box:

1. Read the Terms and Conditions of Sale below.
2. Check to make sure the following materials are included:
  - 3 measuring tapes (200', 300' & 400')
  - 2 strings on reels
  - 8 screwdrivers
  - 1 TPF Accessory Kit (Football, Soccer, Lacrosse or Field Hockey) including a TPF Layout Guide
3. For Soccer or Field Hockey install Circle & D Bolt onto your painter, for Lacrosse install the Crease Bolt – follow the instructions included in the box.
4. Check your paint supply (order more if necessary).

### TERMS AND CONDITIONS OF SALE

#### Limited Warranty:

1. Swaim Bros. Field Painting (SBFP) guarantees all products to be free of defects in materials and workmanship for one (1) year from the original date of purchase (not the date first used). The warranty on a 2nd incident is also from the original purchase date.
2. This warranty applies to the first customer only and not to subsequent owners. If a product fails due to defects in material or workmanship during the warranty period, SBFP will repair it or replace it with the original item purchased.
3. SBFP's maximum liability hereunder is limited to the purchase price of the product. SBFP will not be liable for any labor charges or freight costs incurred in connection with replacement of a product.
4. This warranty does not cover defects due to negligence, misuse, improper installation, acts of God, fire or casualty or failure to exercise normal maintenance, or for the consequences of uses for which products were not designated.

**EACH OF THESE LIMITED WARRANTIES IS EXPRESSLY IN LIEU OF ALL OTHER EXPRESS WARRANTIES. IMPLIED WARRANTIES SHALL BE LIMITED TO THE DURATION OF EACH EXPRESS WARRANTY PERIOD. WE SHALL UNDER NO CIRCUMSTANCES BE LIABLE FOR ANY SPECIAL, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL LOSS OR DAMAGES RESULTING FROM THE USE OF A PRODUCT.**

All purchases of SBFP goods shall be governed by the laws of the State of California, including the Uniform Commercial Code as in effect on the date of the purchase. The purchaser of the goods agrees that any proceeding brought in connection with the purchase of goods shall be brought in any court of competent jurisdiction in California.

### Damages and Claims:

- All products are shipped from our offices in Encinitas, California, meaning title and risk of loss and damage pass to you upon our transfer of product to carrier. It is understood that all claims for damages to or loss of material in transit shall be filed by the buyer directly with the carrier.
- If packages are received damaged, please note this on carrier's receipt. Be sure to save all damaged cartons and packing materials to present to carrier when filing claim.
- If a claim for damage incurred during shipping, apparent or concealed, is made with the carrier SBFP must receive notification in writing (to the address below or via email at [info@theperfectfield.com](mailto:info@theperfectfield.com) within seven (7) days after receipt of merchandise to receive credit. Failure to do so shall constitute acceptance of the merchandise and waive any future claims.
- Any action for breach of this warranty must be commenced within one (1) year after the cause of the action has occurred, or it shall be forever barred.

### Return of Products:

- No product is to be returned to SBFP without prior approval. We will provide a factory Return Authorization that must accompany your return of the product to us.
- Return freight is your responsibility unless the product was shipped in error.
- Credit or replacement will only be made if we determine that the product is defective or was shipped in error. Authorized returns for a product that is neither defective nor shipped in error are subject to a 25% restocking fee with return freight your responsibility.
- Only authorized returns received in good re-sellable condition within 30 days of original purchase date will be accepted for credit.
